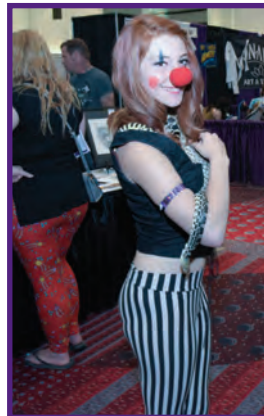
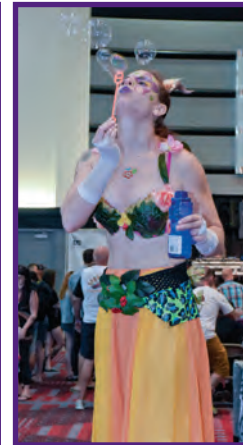

## **TATTOO BOOTH RENTAL CONTRACT**

*Welcome to Tattoo Masquerade® 2017!*

Please read all of the information detailed herein prior to executing and returning this contract.

### **I. TERMS & REQUIREMENTS**

- All tattooing artists are required to pass gear inspection on Thursday evening (6/1/17) or Friday morning (6/2/17), prior to the start of the event. Failure to do so will result in a forfeiture of your Tattoo Booth reservation, without refund or recourse.
- You hereby understand that you are solely responsible for undergoing your own gear inspection, and agree that you will be present for said gear inspection at the times posted (TBD). You hereby acknowledge that you will not be allowed to enter your tattoo booth prior to receiving gear inspection approval.
- You must be present with your gear set-up in a “ready-to-work” fashion for inspection, and must meet all of Denver’s Department of Environmental Health requirements. Additionally, you must pay any applicable licensing fees related to the event (*i.e.*, temporary body artist fees, if applicable).
- Tattoo Masquerade® makes no claims and offers no guarantees as to event attendance. No painting, nailing, and/or use of thumbtacks is allowed on any of the Colorado Convention Center’s or Brede Exhibition Services’ surfaces. All boothholders are responsible for their booths and the space within a five-foot area from the outer perimeter of their booths.
- We strongly recommend the use of pre-sterilized and pre-packaged disposable tubes and needles.
- No sales of any tattoo equipment to non-licensed, non-certified individuals will be allowed at the event.
- No branding, piercing, or scarification is permitted on-site.



## II. DENVER DEPARTMENT OF ENVIRONMENTAL HEALTH REQUIREMENTS

- ***Each tattoo artist must have a bloodborne pathogens (“BBP”) training certificate, valid through June 4, 2017 and issued by a Denver-approved BBP training program (please refer to the attached BBP Addendum for the list of approved Denver-approved BBP issuers; only valid BBPs provided by issuers on the Denver-approved list will be accepted, no exceptions).***
- Each tattoo artist must have a state-issued photo ID and either a Denver or Temporary Body Artist License, valid through June 4, 2017 (a Temporary Body Artist License application is attached herein).
- Each booth must maintain a written event exposure control plan and offer client release and aftercare forms.
- No food or drink are allowed in the tattoo booths at any time.
- Nobody under the age of 18 will be permitted to receive tattoo work at this event (***no exceptions***; regardless of state or local laws, any tattoo artist found tattooing anyone under the age of 18 will be ejected from the event and all booth fees will be forfeited).
- Client chairs and work tables must be wiped down with single-use, disposable, EPA-approved tuberculocidal wipes (such as those manufactured by Opti-Cide 3 and CaviCide1).
- All sharps must be properly disposed of in approved sharps containers (sharps containers will be provided).
- All tattoo equipment must be sterilized (an on-site sterilization station will be provided).

We suggest keeping copies of all submitted documents for your files.

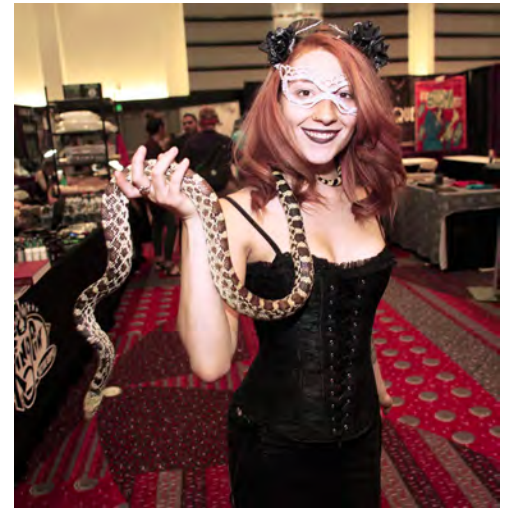

#### IV. TATTOO BOOTH RENTAL FEE: \$650

**10'x10' Tattoo Booth; Tattoo Booth Rental Fee does not include a \$25 Temporary Body Artist License application fee, per artist, as required by the City and County of Denver for all tattoo artists who are not licensed in Denver.**

- Full payment, including all applicable Temporary Body Artist License application fees (if any), must be received to hold your booth reservation.
- Tattoo Booth includes: two (2) tables, four (4) chairs, one (1) garbage can, one (1) biohazard waste container, one (1) ID sign, two (2) artist lanyards, four (4) 3-day wristbands (two for working tattoo artists and two for assistants), and power.
  - Please contact Sabrina Carlson of Brede Exposition Services at (303) 399-8600 to arrange and submit payment for any extra booth items (*e.g.*, additional tables, chairs, etc.) and/or shipping/receiving needs. Boothholders are responsible for all costs associated with any additional booth items and shipping/receiving. An Exhibitor Service Manual detailing additional booth items and associated pricing will be provided by Brede Exposition Services at least sixty (60) days prior to the event.

#### Additional Tattoo Booth Terms

- All tattooing must be completed by the event closing times. If you are still tattooing after the event closing times, you will be assessed a non-prorated fee of \$500/hour.
- Tattoo Booth Rental Fee does not include local public fees (*i.e.*, Denver Department of Excise and Licenses fees).
- Every working tattoo artist is required to complete and return all appropriate documentation, including a copy of the following: Denver-approved BBP (must be valid through June 4, 2017), state-issued photo ID, Denver Body Artist License (must be valid through June 4, 2017), and/or a completed Temporary Body Artist License application (if applicable).
- Every working tattoo artist must pass both the Tattoo Masquerade® and Denver Department of Environmental Health inspections on Thursday evening (6/1/17) or Friday morning (6/2/17), prior to the start of the event.
- WiFi access – The Colorado Convention Center only provides complimentary WiFi access on the facility's street level (*not in the event ballroom*). If you require dedicated WiFi access in your booth, please contact Stephanie Garcia of Smart City Networks at (303) 228-8056 to arrange/submit payment for such (the event will be held in the Four Seasons Ballroom). Boothholders are responsible for all costs associated with dedicated WiFi access. Please refer to the attached **WiFi Addendum** for details.
- Two (2) tattoo artists and two (2) assistants per Tattoo Booth are allowed; if you require additional space, please consider renting a double booth.

I assume all responsibility and liability for any claims, damages, and/or losses arising from myself or associated artists while on the premises of the Colorado Convention Center, and I will indemnify and hold harmless the Colorado Convention Center (and its agents, employees, and subcontractors) and Tattoo Masquerade® (and its members, officers, volunteers, employees, and subcontractors) from any and all such claims, damages, and/or losses.
